GENERAL INFORMATION: Tax Code Section 26.04(c) requires an officer or employee designated by the governing body to calculate the no-new-revenue (NNR) tax rate and voter-approval tax rate for the taxing unit. These tax rates are expressed in dollars per \$100 of taxable value calculated. The calculation process starts after the chief appraiser delivers to the taxing unit the certified appraisal roll and the estimated values of properties under protest. The designated officer or employee shall certify that the officer or employee has accurately calculated the tax rates and used values shown for the certified appraisal roll or certified estimate. The officer or employee submits the rates to the governing body by Aug. 7 or as soon thereafter as practicable.

School districts do not use this form, but instead use Comptroller Form 50-859 Tax Rate Calculation Worksheet, School District without Chapter 313 Agreements or Comptroller Form 50-884 Tax Rate Calculation Worksheet, School District with Chapter 313 Agreements.

Water districts as defined under Water Code Section 49.001(1) do not use this form, but instead use Comptroller Form 50-858 Water District Voter-Approval Tax Rate Worksheet for Low Tax Rate and Developing Districts or Comptroller Form 50-860 Developed Water District Voter-Approval Tax Rate Worksheet.

The Comptroller's office provides this worksheet to assist taxing units in determining tax rates. The information provided in this worksheet is offered as technical assistance and not legal advice. Taxing units should consult legal counsel for interpretations of law regarding tax rate preparation and adoption.

#### SECTION 1: No-New-Revenue Tax Rate

The NNR tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that would produce the same amount of taxes (no new taxes) if applied to the same properties that are taxed in both years. When appraisal values increase, the NNR tax rate should decrease.

The NNR tax rate for a county is the sum of the NNR tax rates calculated for each type of tax the county levies.

While uncommon, it is possible for a taxing unit to provide an exemption for only maintenance and operations taxes. In this case, the taxing unit will need to calculate the NNR tax rate separately for the maintenance and operations tax and the debt tax, then add the two components together.

#### SECTION 2: Voter-Approval Tax Rate

The voter-approval tax rate is the highest tax rate that a taxing unit may adopt without holding an election to seek voter approval of the rate. The voter-approval tax rate is split into two separate rates:

- 1. Maintenance and Operations (M&O) Tax Rate: The M&O portion is the tax rate that is needed to raise the same amount of taxes that the taxing unit levied in the prior year plus the applicable percentage allowed by law. This rate accounts for such things as salaries, utilities and day-to-day operations.
- 2. Debt Rate: The debt rate includes the debt service necessary to pay the taxing unit's debt payments in the coming year. This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The voter-approval tax rate for a county is the sum of the voter-approval tax rates calculated for each type of tax the county levies. In most cases the voter-approval tax rate exceeds the no-new revenue tax rate, but occasionally decreases in a taxing unit's debt service will cause the NNR tax rate to be higher than the voter-approval tax rate.

# A RESOLUTION OF THE BOARD OF DIRECTORS OF BRUSH COUNTRY GROUNDWATER CONSERVATION DISTRICT ADOPTING THE 2024 TAX RATE FOR THE DISTRICT

WHEREAS, Brush Country Groundwater Conservation District ("District"), a political subdivision of the State of Texas, was created by Senate Bill 2456, Act of the 81<sup>st</sup> Texas Legislature, Regular Session, codified at Chapter 8852 of the Texas Special District Local Laws Code ("Enabling Act"), and pursuant to the authority of Article XVI, § 59 of the Texas Constitution, as a groundwater conservation district operating under Chapter 36, Texas Water Code, and the District's Enabling Act;

WHEREAS, the Enabling Act for the District establishes in Section 8852.151 the District may not impose ad valorem taxes at a rate which exceeds three cents (\$0.03) on each \$100 of valuation of taxable property in the District;

WHEREAS, pursuant to Section 8852.005 of the Enabling Act, Chapter 36 of the Texas Water Code is applicable to the District;

WHEREAS, Section 36.201(c) of the Water Code provides that the District may not levy a tax to pay the maintenance and operating expenses of the District until the tax is approved by a majority of the electors voting at an election in the District held for that purpose;

WHEREAS, Sections 8852.003 and 8852.023 of the Enabling Act require the District to place a ballot item before the voters within the initial District territory, as defined by Section 2 of the Enabling Act, to confirm the District and the District imposition of a maintenance tax and such ballot item must instruct the voters of the initial District territory to vote for or against the creation of the District and the levy of a maintenance tax to operate the District not to exceed three (3) cents for each \$100 of assessed valuation;

WHEREAS, the required ballot item was placed on the November 3, 2009 ballot and the voters within the initial District territory in Brooks County, Hidalgo County, Jim Hogg County, and Jim Wells County outside of the City of Alice approved confirmation of the District and the levy of a maintenance tax not to exceed three cents (\$0.03) for each \$100 of assessed valuation;

WHEREAS, pursuant to Section 36.203 of the Water Code, the District considered the income of the District from sources other than taxation in setting the District's tax rate;

WHEREAS, Section 36.204 of the Water Code establishes that the Texas Tax Code governs the appraisal, assessment, and collection of District taxes;

WHEREAS, the District is required to comply with Section 26.05(a) of the Tax Code by adopting a tax rate for the current tax year;

WHEREAS, the District calculated and published or provided actual notice of a meeting on and a proposed tax rate of \$0.010791 for each \$100;

WHEREAS, because the proposed tax rate is 50 cents or less per \$100 of taxable value and the proposed tax rate would impose taxes of \$500,000 or less when applied to the current total value for the District, the District notice of the proposed tax rate and meeting satisfies Texas Tax Code Section 26.052

WHEREAS, a tax rate of \$0.010791 for each \$100 of assessed valuation will raise more revenue for maintenance and operations than last year's tax rate; and

WHEREAS, to satisfy the requirements of Section 26.05(b) of the Tax Code, the District may not impose property taxes in any year until the District's Board has adopted a tax rate for that year, and the annual tax rate must be set by resolution of the Board of Directors.

WHEREAS, the Board of Directors for the District believes it is necessary to adopt a tax rate of \$0.010791 for each \$100 of assessed valuation to enable the District to adequately fund its activities and operations as the District begins to carry out the purposes for which the District was created.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF BRUSH COUNTRY GROUNDWATER CONSERVATION DISTRICT THAT:

- Section 1. The Board of Directors adopts a tax rate for tax year 2024 of \$0.010791 per \$100 of value for the operations and maintenance of the District; and,
- Section 2. THIS TAX RATE WILL RAISE MORE REVENUE FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE; and,
- Section 3. This Resolution be provided to the tax assessor as certified notice of the adopted tax rate; and
- Section 4. The President of the Board of Directors and his designees are further authorized to take all necessary action to implement this resolution; and,
- Section 5. This resolution shall take effect immediately upon adoption.
